

The Common Council of the City of Connersville held their regular meeting on Monday, October 21, 2024, at 7:00 P.M. in the Council Chambers at City Hall.

Councilwoman McQueen led the Pledge of Allegiance and Reverend Eric Hopkins offered an invocation before the start of the meeting.

Council President Diana Phillips presided and called the meeting to order with Councilwoman Sharon McQueen, Councilman Tommy Lee Williams Jr., Councilman Brian Robb, Councilman Bill Gray, and Councilman Jabin Collins were present. Attorney Geoff Wesling was also present. Mayor Chad Frank and Councilwoman Jenny Barrett were absent.

Councilman Williams Jr. made a motion to approve the minutes of the October 7, 2024, regular meeting; Councilwoman McQueen seconded the motion. All Council members voted "yes."

Clerk Treasurer Rosemary Brown presented **Pending Ordinance 3962**, an ordinance establishing all 2025 Salaries. Councilwoman McQueen made the motion to approve **Pending Ordinance 3962** on first reading, Councilman Robb seconded the motion. All Council members voted "yes".

Councilman Gray made the motion to suspend the Rules on **Pending Ordinance 3962** and move on to Third and Final Reading; Councilman Robb seconded the motion. All Council members voted "yes."

Councilman Robb made the motion to approve **Pending Ordinance 3962**; on Third and Final Reading; Councilman Gray seconded the motion. All Council members voted "yes".

Clerk Treasurer Rosemary Brown presented **Pending Ordinance 3963**, an ordinance deleting a handicap stop at 310 West 12<sup>th</sup> Street. Councilman Gray made the motion to approve **Pending Ordinance 3963** on first reading, Councilman Robb seconded the motion. All Council members voted "yes".

Councilwoman McQueen made the motion to suspend the Rules on **Pending Ordinance 3963** and move on to Third and Final Reading; Councilman Gray seconded the motion. All Council members voted "yes."

Board President Diana Phillips presented **Pending Ordinance 3964**, an ordinance approving the Professional Firefighters Local 2205 Contract. Clerk Treasurer Rosemary Brown requested approval of **Resolution 2024-60**, a resolution to reimburse Three Thousand Nine Hundred Sixty-Two and 50/100 dollars (\$3,962.50) into Park 227 Pool Chemicals; and **Resolution 2024-61**, a resolution transferring Five Thousand and 00/100 dollars (\$5,000.00) from Council 114 City Engineer to 2495 Celebrations in the Ville. Councilwoman McQueen made the motion to approve **Resolution 2024-60 and -61**, Councilman Williams Jr. seconded the motion. All Councilmembers voted "yes".

Council President Diana Phillips asked everyone to get out and vote.

Clerk Treasurer Rosemary Brown announced that City Hall will be closed Tuesday 10/22 from noon to 2 pm; the Park's Truck or Treat is Tuesday 10/29 from 5-7 pm; and Halloween Trick or Treat is Thursday 10/31 from 5 – 7 pm.

Councilwoman Sharon McQueen announced that the Art Association and Downtown vendors will also have trick-or-treat on Halloween from 5-7.
