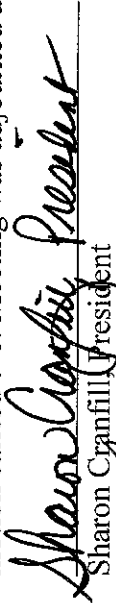
Linda Fitzgerald spoke on behalf of Healthy Fayette County and talked about the benefits of creating Blue Zones.

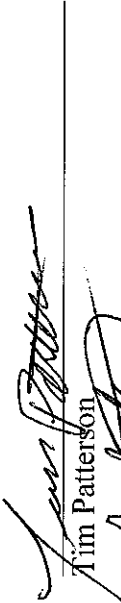

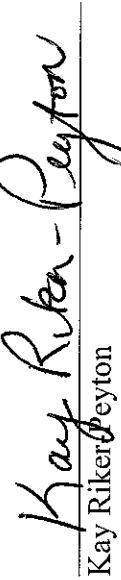
